



Regulation No. ... of the Rector of the University of Lodz of

regarding: the schedule of payment of benefits for students and doctoral students of the University of Lodz, including foreigners, in the academic year 2023/2024

According to: Article 23(1) of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws of 2023, item 742, as amended), it is ordered as follows:

§ 1

- 1. Scholarship benefits awarded under the following types of scholarships:
 - 1) Scholarship Benefit Fund Students;
 - 2) Scholarship Benefit Fund Doctoral students shall be paid in accordance with the provision of paragraph 5, at monthly rates from November 2023 to June 2024, inclusive, in accordance with the period for which they are granted. The November payment also includes benefits for October 2023. The Rector's scholarship is paid from December 2023 to June 2024, inclusive, according to the period for which it was awarded. The payment of this benefit in December 2023 also includes compensation of the scholarship for October and November 2023.
- 2. Scholarship benefits awarded under the following types of scholarships:
 - 1) Fund for doctoral students;
 - 2) Target grant for scientific research shall be paid in accordance with the provision of paragraph 5, at monthly rates from October 2023 to September 2024, inclusive, in accordance with the period for which they were granted.
- 3. Scholarships of the Minister of Education and Science for significant achievements for students awarded to UL Students are paid once within 14 days of crediting the University's account with funds earmarked for this purpose, but no sooner than after being awarded by the Minister in charge of Higher Education.
- 4. Scholarship benefits awarded under the following types of scholarships:
 - 1) Gen. Wł. Anders scholarship programme for Polish community students;
 - 2) Gen. Wł. Anders scholarship programme for Polish community doctoral students or interns with a master's degree;
 - 3) Stefan Banach scholarship for students:
 - 4) Stefan Banach scholarship for doctoral students;
 - 5) In solidarity with Belarus,

- 6) In solidarity with Ukraine shall be paid in accordance with the provision of paragraph 6, at monthly rates from October 2023 to September 2024, inclusive, in accordance with the period for which they are granted.

§ 2

- 1. In the implementation of the payment of benefits specified in § 1(1) and § 1(3), the rules set forth in Appendix 2 to the Regulations of scholarship benefits for students and doctoral students of the University of Lodz shall apply.
- 2. Scholarship Lists:
 - 1) referred to in § 1(1-4) shall be signed by the person preparing the payment;
 - 2) referred to in § 1(1) and (3) shall be approved for payment by the director of the COSSiSSiD of the University of Lodz;
 - 3) referred to in § 1(2) shall be approved for payment by the director of the CSD of the UL;
 - 4) referred to in § 1(4) shall be approved for payment by the Director of the BWZ or their deputy;
 - 5) after meeting the provisions of subsections 1-3, the lists should be submitted to the Finance Department a minimum of one day before the transfer date, as specified in § 1(5) and (6), executed by the UL to the bank;
 - 6) can be printed only after the scholarship period is closed.

§ 3

The Regulation shall enter into force on the date of signature.
